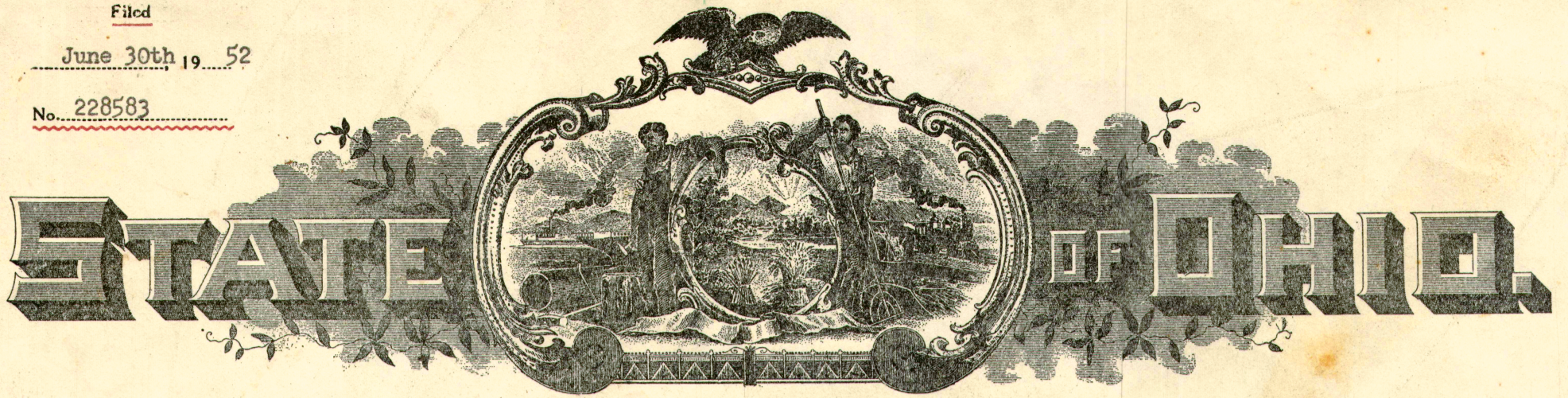

ARTICLES OF INCORPORATION

The undersigned, a majority of whom are citizens of the United States, desiring to form a corporation, not for profit, under the General Corporation Act of Ohio, do hereby certify:

FIRST. The name of said corporation shall be COLONIAL HILLS CIVIC ASSOCIATION, INC.

SECOND. The place in this State where the principal office of the corporation is to be located is _____

Sharon Township, _____ Franklin County.

THIRD. The purpose or purposes for which said corporation is formed are:

promoting the general welfare of the area known as Colonial Hills, by giving special attention to public improvements and safety and all that relates to the betterment thereof and the convenience, comfort and safety of the residents thereof; encouraging social intercourse and unity among its members; and doing any and all things necessary or incident thereto.
